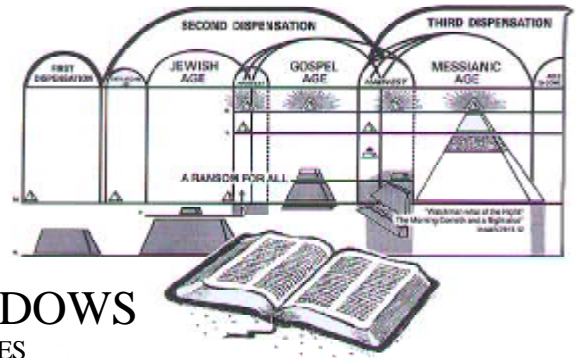

1. A. After the Atonement Day sacrifices of the Gospel Age are completed and the Mediatorial phase of the Kingdom begins its operation, the people will present sacrifices to the glorified royal PRIESTHOOD.

B. This was typified by the GENERAL OFFERINGS offered by Israel after their Day of Atonement.

C. At the present a worldly, wealthy man can use his "mammon" to make for himself FRIENDS.

D. Whosoever shall give even "a cup of cold water" to one of the least of a prospective body member (priest) shall by no means lose his REWARD. — Luke 16:1-8; Matthew 10:42

2. The sacrifices which are not the "Day of Atonement sacrifices" belong to the MILLENNIAL Age.

3. A. The "Day of Atonement" sacrifices were a BASIS for the general forgiveness and acceptance with God of all Israel.

B. Trespasses by individuals, after the sacrifices of the Gospel Age, will require CONFESSION and RECONCILIATION.

4. A. The "Atonement Day" sacrifices of the Christ represented the cancellation of ADAMIC sin.

B. While the world is gradually being restored to actual perfection and life and harmony with God, after the highway of holiness is opened, any individual who commits errors must make some AMENDS, accompanied by REPENTANCE if he wishes to be in harmony with God through Christ.

5. A. Consecration, after the highway of holiness is opened, will be unto LIFE.

B. Consecration must always be a VOLUNTARY presentation of one's powers.

6. A. The offerings of the people in Israel after the "Day of Atonement" pointed back to the SACRIFICES of that day.

B. The articles offered depended upon the ABILITY of the offerer.

7. A. After the highway of holiness is opened all men will come to an accurate knowledge of the TRUTH — I Timothy 2:4

B. Adamic death includes all the sickness, pain, and IMPERFECTION to which humanity is now subject.

C. Only those who refuse or neglect the opportunities held out after the highway of holiness is opened will die the 2ND DEATH. — Acts 3:23

D. Perfection will come GRADUALLY and will require the co-operation of the sinner's will ever to reach it.

E. The "burnt offerings and peace offerings" following the Gospel Age sacrifices represent the people as CONSECRATING.

F. These offerings do not represent sin offerings to secure ATONEMENT.

8. A. At the end of the Millennial Age, by which time all the obedient shall have been brought to perfection, each will be able to offer his perfect self, typified by a "BULLOCK". — Psalm 51:19

B. All these sacrifices must be of the FREE WILL and desire of the offerer. — Leviticus 1:3

9. A. The completeness of consecration was shown by the DEATH of the animal.

B. Those who consecrate will be accepted as HUMAN beings and will be perfected as such.

C. The consecrations represent an appreciation of the RANSOM and the acquiescence of the offers to the LAW of God.

10. A. The burnt offerings of the priests were to be kept up CONTINUALLY on the altar.

B. The fire was to ever be BURNING upon the altar.

11. A. This represented that the offerings would be acceptable because of GOD'S ACCEPTANCE of the Atonement Day sacrifices.

B. The free will offering serves to typify a thankful PRAYER to the heavenly Father.

12. A. The people's peace offerings could be made either in fulfilment of a vow or as a willing "THANK OFFERING".

B. The offerer must EAT the sacrifice.

13. A. If any will come into a condition of full peace and harmony with God, he must fulfil a covenant before God of entire CONSECRATION to him.

B. If after being perfected, one becomes defiled, as shown by the penalty of touching unclean things, he must die (the 2ND DEATH).—Leviticus 7:19-21

14. A. The unleavened cakes mingled with oil and anointed wafers represented the offerer's faith in Christ's CHARACTER.—Leviticus 7:11-13

B. Leaven is a type of SIN.

15. The people's meat offerings, of fine flour, probably represented PRAISES and worship offered to the Lord by the world, through his church.

16. A. If a person in Israel committed a sin through ignorance, he was guilty and had to bring a ram without blemish and money, with a FIFTH more.—Leviticus 5:15-19

B. If a person sinned knowingly he had to restore the principal with 20 % interest and bring a ram for the trespass offering unto the Lord.—Leviticus 6:1-7

17. A. For every wrong RESTORATION must then be made, with interest, accompanied by repentance.

B. The value of the ransom was shown by the RAM presented.

18. A. Sin offerings of the "Day of Atonement" were offered to JUSTICE in the "Most Holy."

B. Sacrifices after the "Day of Atonement" were offered to the priests. A portion was offered to the Lord, but the priest ate the REMAINDER.

19. A. The world will present themselves to the ROYAL PRIESTHOOD for forgiveness of trespasses.

B. The acceptance of their consecrations will signify FORGIVENESS—John 2:23

20. Can a member of the Royal Priesthood now say to those who believe and repent, "Thy sins are forgiven thee"? YES

21. A. The offerings of the Atonement Day were always BURNED.—Leviticus 6:30; Hebrews 13:11

B. The trespass-offerings offered after the Day of Atonement were EATEN (appropriated) by the priests.

22,23. A. Our Lord and the holy angels are scripturally referred to as MALES.

B. The saints are together represented as a female, a "VIRGIN".

C. The human female was originally a part of the MAN made in God's image.

D. The headship remained with ADAM who was the care-taker of Eve.

24. A. By the close of the Messianic Age, the willing and obedient will be restored to the perfect condition represented in ADAM before Eve was created.

B. Will the people lose their identity? NO

C. Who was the perfect man who died for Adam? JESUS

D. Is Eve included in the "ransom for all?" YES

25. A. The Gospel church will be the bride of the risen and highly exalted CHRIST.

B. At the second advent our glorified Lord claims his BRIDE as his own.

26. A. After the church is glorified, all FEMININITY will be dropped.

B. As the body of the great Prophet, Priest, and King, the CHURCH will be a part of the life-giver to the world.—Isa. 9:6

27. A. The MALES of the priestly tribe, alone did the sacrificing.

B. During the Gospel Age, male APOSTLES, male PROPHETS, male EVANGELISTS, and male PASTORS and TEACHERS have been given for the qualification of the saints...—Ephesians 4:11,12

C. Are women to teach or usurp authority over the man?—I Tim. 2:12 NO
